<u>Discipline Regulation Changes</u> 2024-2025

Commence 1st July 2024

- Respect Sanctions 6/10/15 have been removed and will no longer tally in the background
- Sinbin caution is now a STANDARD caution and will have a £12.00 admin fee attached
- No Fines will be imposed for Proven Misconduct Charges for all Youth participants playing in under 18 Youth designated competitions
- Fines will be applied for Proven Misconduct charges where the participant is aged between 16-18 playing in open aged football

Penalty Points will be awarded for the following offences only during the season

- Penalty Points threshold of 75 Points per team has been removed and replaced with as follows: -
- Where a team accumulates 25 penalty points during a playing season, that team's Club shall
 be issued with a warning which may (amongst other things) include details as to how the
 Club may seek assistance from its Affiliated Association to improve its disciplinary record.

- Where a team accumulates **50 penalty points** during a playing season, a fine of £75 shall be imposed on that team's Club.
- Where a team accumulates **100 penalty points** during a playing season, a Charge shall be issued against that team's Club and, where proven, the following sanctions may be imposed:
 - o 94.1 a fine;
 - o 94.2 the imposition of an action plan;
 - 94.3 the suspension or cancellation of that Club's affiliation and/or England Football accreditation status; and/or
 - 94.4 an order that a subsequent Charge may be brought against the Club in the event that the same team accumulates a specified number of additional penalty points

- *Threatening Behaviour Fined of up to £200.00 Mandatory Minimum £100.00
- *Physical Contact towards the Match Official Fined £250.00 Mandatory Minimum -£150.00
- *Assault on a Match Official
- Assault Participant on Participant Discretion of the Panel
- *Aggravated Breaches Discretion of the Panel
